**General Info** 5th classified growth in 1855. The name of Grand-Puy comes from the old expression

"puy" which means "hill, little hill", and this land is mentioned in documents dating from the Middle Ages. Indeed, the vineyard extends on one of the ridges of land which were made the first wines of the Medoc. Since the sixteenth century, the thought has passed from generation to generation and, by way of alliances between families, he stayed within the same descent until 1920, before resuming a destiny with Borie family in 1978. Under the leadership of François-Xavier Borie (Chateau Ducru-Beaucaillou), GP Lacoste is the perfect example of a classic Pauillac, tannic and full bodied. A wine for keeping, which makes part of the top of the Medoc wines.

Vintage While the 2017 vintage began with a very dry winter, temperatures were very mixed,

with a very cool January and a rather mild February. Thus, bud break began around March 20th for the earliest Merlots. By mid-April phenological stages were on

average ten days ahead of 2016, similar to the vintage of 2014.

The last two weeks of April saw two episodes of heavy morning frost in the Bordeaux vineyard. However, thanks to the proximity of the Estuary, our red grapes were not

affected and produced satisfactory yields.

The first flowers appeared ten days earlier than the average dates recorded over the past twenty years, and flowering and fruit set occurred in very favourable conditions. Early summer saw high temperatures while water stress became apparent, notably on the gravelly soils. However, this phenomenon was attenuated with the return of rain at the end of June.

The summer of 2017 particularly dry, relatively sunny but quite cool despite sporadic peaks in temperature, confirmed that the vintage would continue its early

development through to harvest.

Vineyards The vines of this Fifth Growth chateau stretch across 58 hectares of the Pauillac commune, lying across well-

draining gravel soil. The result is a concentrated, polished wine, showing classic Pauillac notes of dark berries, plum, spices and earth. These bottlings are dominated by Cabernet Sauvignon, which benefits from the deep gravel topsoil with a limestone basis. The Cabernet provides structure which allows these wines to generally outperform their classification. There's good aging potential here too. The estate produces a second wine called Lacoste-Borie. 90 hectares around the castle. Grape varieties of vines 75% Cabernet Sauvignon - Merlot 20% -

5% Cabernet Franc; 10,000 vines / hectare; Average vine age 38 years.

**Harvest** Hand-picked from September 15th to 29<sup>th</sup>, 2017.

Maturation Two successive selections before and after the destemming process. A long period of maceration (about 3

weeks). Ageing in French oak barrels (75% new barrels each vintage) for between 16 to 18 months depending on

the vintage.

**Tasting Notes** The assemblage of Grand-Puy-Lacoste 2017 is dominated by Cabernet Sauvignon (80%) permitting our terroir to express the character and charm of our splendid Cabernets. The wine is a deep, bright ruby color. The bouquet

releases scents of ripe red fruit, violets, and spices. This is complimented by an attractive fresh minerality. On the palate, the attack is precise, clean and long, with its ripe and melted tannins. Overall, this is a wine of great balance, allying charm, elegance and freshness; it is aromatic, with an aftertaste of considerable purity. This 2017 breaks the mould of vintages ending in "7" as it demonstrates the richness of expression of the wonderful

terroir of Pauillac, combining balance, refined fruit and ripe tannins.

"The 2017 Grand-Puy-Lacoste was bottled at the end of June. Brambly black fruit, wild hedgerow, cedar, and a touch of wild mint. This is classic "GPL". "The 2017 Château Grand-Puy-Lacoste is an 80/20 split of Cabernet Sauvignon and Merlot that was harvested between the 15th and 29th of September. Yields were a solid 45 hectoliters per hectare. This medium-bodied, fresh, lightly textured 2017 is a perfect example of the vintage with its charming, ripe, yet more mid-weight style. Classic Pauillac cassis, lead pencil, leafy herbs, and gravelly minerality all emerge from the glass. It's going to benefit from just short-term cellaring and keep for a decade or more. Barrel Sample: 89-92."

"This has a thrilling nose which, in spite of the weighty dominance of Cabernet, is perfectly red-fruited and sonorous. This is a sleek thoroughbred with power and grace, and it is layered with flashes of both red and black fruit on the palate. The finish has more muscle and more tannin looms as the flavour senesces on the back of the palate and the result is a game of flamboyance and reticence warning the drinker that while the flavour entices you in, there is also the need to exercise restraint because this is a not a wine for drinking in the short term in spite of its apparent precocity. Throughout the flavour there is levity, and this is what makes this powerful wine such an unequivocal success. François-Xavier Borie agrees with this character. He smiled – 'don't forget we are serious'."
