General Info Ch. Sénéjac is one of the better known Crus Bourgeois of the Haut-Médoc, located

near to the vineyards of Margaux, just outside Parempuyre in the far south of the Haut-Médoc region. Sénéjac is a historic estate of 150 hectares, of which only 38 are under vine, and even in the middle of the 19th century produced 100,000 bottles, not far short of its modern-day total. It s reputation for making high quality wine blossomed in the 1980s and then in 1999 it entered a new era when it was bought by Lorraine Cordier, whose family also owned the famous St Julien property, Chateau Talbot. Recently the estate has changed hands and is now owned by Monsieur

Rutsman.

Vintage The problem with the appellation of Haut-Médoc is that they are so dependent on

Cabernet Sauvignon, the late ripening variety that had such difficulty achieving full ripeness in 2012. The whole season, in stark contrast to 2011, was so late, with horrid weather during flowering resulting in very uneven ripening even on the same bunch. Lots of unsettled weather in spring and early summer was followed by an unusually hot, dry summer - so much so that the ripening process shut down completely at times. By early September Cabernets were a long way from achieving not just

phenolic but even sugar ripeness.

Vineyards Chateau Sénéjac is located in the Haut Medoc appellation, spread out over 150

hectares. The property has 39 hectares under vine, planted with 48% Cabernet Sauvignon, 37% Merlot, 11% Cabernet Franc and 4% Petit Verdot. The average age of

vine is around 35 years.

Vinification/ Grapes are hand-picked and sorted, then after the final wine is blended, matured in

Maturation French oak barrels for 12-15 months, using at least 30% new oak.

Tasting Notes This wine is characterized by a deep color, almost black in its younger years. The

expressive nose shows aromas of black fruits and spices. In the mouth has intensity while remaining smooth and civilized with its fine tannins. This is a charming and distinguished wine to drink young to its fullness and fruit, or even better to age slowly

to find the characteristics of its terroir.
