Cantenac-Brown estate once formed part of Boyd-Cantenac, founded by Irishman Jacques Boyd in 1754 and later passed on within the family to Scottish socialite John Lewis Brown - who unfortunately became bankrupt. Designed by Brown in a traditional Tudor style, the château was host to the grand parties the owner was renowned for, highlighting his love of good wines. Sold in 1843 to a banker (Gromard), the owner in 1855, when the estate was granted a Grand Cru classification. Cantenac-Brown, also building the striking brown-brick château. Hard times were around the corner (phylloxera, war, depression) and by 1968, the estate was quite ready for the overhaul the Du Vivier family gave it. Rejuvenation continued under AXA Millésimes (they bought in 1998) and is ongoing today under British businessman Simon Halabi. 150 years later the Simon Halabi family has given new impetus to the estate with the ambition of raising it to the highest echelons.

Vintage

The 2010 growing season was marked by a dry climate throughout the country. The winter was very cold, with temperatures 2 to 3 ° C below average thirties. The campaign began with a very mild April, May was then much cooler. Subsequently, the climate was broadly fees for the second consecutive year, morning frosts occurred at the time of harvest, October 18. The global exposure of the 2010 season is important and close to that of 2009. The highlight is the exceptional duration of sunshine in April, which was almost summer. 2009 and 2010 are two seasons of strong sunlight, with exposure times greater than the reference year 2005.

Vineyards

The 54-hectare Bordeaux wine vineyard of Cantenac Brown sits on gravel and sandy soils. Planted to 65% Cabernet Sauvignon, 25% Merlot and 10% Cabernet Franc, the average age of the vines are 35 years of age. The current blend in the vineyards shows an increase in Cabernet Franc. The terroir is gravel and sand. The vines are planted to a density of 8,500 vines per hectare. Yields are high, averaging 55 hectoliters per hectare. The estate takes a sustainable approach to their Left Bank vineyard farming techniques. This approach means only plant-based fertilizers are used.

Harvest

The grapes are hand-picked and screened on site before being transported in trays to stainless steel temperature-controlled vats. Between the destemming and crushing procedures, the grapes are screened once again on a vibrating table before being taken into the vat house. The weather, fine until the end, was our best ally. Autumn gave us a beautiful Indian summer with cool nights and sunny afternoons and soft. Plots harvested faster changing foliage color than the others, as if they let themselves go after having given everything. The Merlot was picked Sept 29, 30, Oct 1, 5 & 6. The Cabernet Franc was picked October 7, and the Cabernet Sauvignon was picked between 13-20 October.

Maturation

Alcoholic fermentation lasts for around ten days and is followed by the Malolactic fermentation in the barrels and vats. The plots are vinified separately according to grape variety and age, which allows for great precision in selection when Château Cantenac Brown is finally blended. After blending, the wine is aged for 12 to 15 months in oak barrels (made of split oak staves from the forests of central France). 60% of the barrels are new whilst the remaining 50% are 1 year old.

Tasting Notes

Like Brane-Cantenac, Cantenac Brown is one of the big outperformers in Margaux this year. Is it better than the 2009? It is probably more a question of taste. The 2010 wine is characterised by ripe black fruits well woven together into a sweet
