Jean-François de Pontet, royal governor of the Médoc, ombined several vineyard plots in Pauillac in the early 18th century. Years later, his escendants added neighbouring vines in a place named Canet. This was the eginning of one of the largest estates in the Médoc, which quite naturally added the ame of its founder to that of the land registry reference. A century later, Pontet- anet was included in the famous 1855 classification, thereby confirming its nembership among the elite of the Médoc. This privileged position did not go nnoticed by one of the most important Bordeaux shippers of the time, Herman ruse, who bought the estate in 1865. He built new cellars, modernised the vinemaking facilities, and established the wine's reputation around the world. The ruse family owned Pontet-Canet for 110 years, until another shipper (from Cognac his time), Guy Tesseron, acquired it in 1975. Currently owned by Guy Tesseron's ons, Alfred and Gérard, this means that Pontet-Canet has belonged to only three

"This impeccably run, biodynamically farmed estate of Alfred Tesseron goes from strength to strength. The 2012 triumphs once again with its notes of dark plum, blackcurrant, licorice and almost a hint of truffle, its full-bodied, supple tannins, and beautiful, expensive mouthfeel. Complex and deep, this dense ruby/purple-colored wine may not be at the level of the 2009 or 2010, but it is a successful wine in this vintage, and a significant wine in 2012. Anticipated maturity: 2017-2035.

"A softer, less powerful and less prodigiously endowed Pontet Canet, the 2012 exhibits notes of creme de cassis and new barrique vanillin followed by a medium-bodied, elegant wine with sweeter tannin (and less of it) than is found in the great vintages that immediately precede it. The 2012 is certainly outstanding and, in fact, many readers may prefer it to the blockbuster, out-of-this-world, over-sized 2010, 2009 and 2008. Medium-bodied, pure and expressive, this classic Pauillac should only require 5-6 years of cellaring. It should drink well for two decades thereafter.

No one will confuse the 2012 Pontet Canet with the 2008, 2009 or 2010, but proprietor Alfred Tesseron has turned in another high level performance in this more challenging vintage (especially true in the Medoc)." - RP, Wine Advocate

"What is a primeur report without one of Pauillac's most dynamic estate? I made the trip through the rain to taste their 2012. A blend of 65% Cabernet Sauvignon, 4% Cabernet Franc, 1% Petit Verdot and 30% Merlot, the latter was cropped from 4th October and the Cabernet Sauvignon from 11th October, finishing six days later. The 50% of the crop once aged in new oak and one-year old barrels are now matured in concrete vats whilst 35% of the crop is aged in clay amphora quarried from their own vineyard. There is certainly great purity and terroir expression on the nose: blackberry, briary and background scents of fresh raspberry and cold stone. The definition is very impressive. The palate is interesting – quite different from the previous vintages. I love the tannins here – very fine but lending the Pontet-Canet great backbone It is utterly harmonious but I feel more understated, perhaps more controlled than recent vintages. The finish is much more introspective – a Pauillac

"(65% cabernet sauvignon, 30% merlot, 4% cabernet franc and 1% petit verdot): Deep purple-ruby. Perfumed nose of violet and ripe blackberry jam. Smooth, rich and almost sweet on entry, then increasingly austere, with the sweet cassis and delicate herbal flavors overshadowed by rising, raw tannins. I detected a slightly green quality on the long finish. Though this wine lacks the amazingly sweet flesh of the '09 and '10 wines, and the classic elegance of the '08, I like its precision. Alfred Tesseron told me the estate picked late, on October 4, to offer the grapes a greater chance of reaching suitable ripeness, but they harvested quickly, using an extra sorting table."

This is also about the same percentage as in the vineyard itself'. Biodynamics brings out the ripeness, they believe, and this does have a vibrancy and purity that you would be so happy to drink. Doesn't feel huge, imagine not high alcohol (they say they haven't done the analysis yet apparently, which sounds hardly believable as surely, they are tracking alcohol levels during vinification?). Certified again 100% biodynamic and organic, harvesting began on October 4th, with third sorting table to ensure they could go quickly once the grapes were picked. They don't use any anti rot treatment apparently. This does not have the power of recent vintages of Pontet Canet, not the richness of the 2009 and 2010, but compensated by other things, such as elegance and plump fruit. "Winemaker Jean-Michel Cosme concedes that the vicissitudes of the vintage made it harder to use organic and biodynamic practices but seems happy with the result. This is a step down from recent stellar vintages, but it's still a dense, if oaky red, with a mixture of leafy, minty and slightly over-ripe flavours. The oak needs to integrate here, but the firm tannins should soften in barrel and bottle. Drink: 2022-30" - TA, timatkin.com

"Produced from an assemblage of 65% Cabernet Sauvignon, 30% Merlot, 4% Cabernet Franc and 1% Petit Verdot, this is one of the darkest wines of the vintage. The nose offers ripe dark berries, licorice, clay, minerality and fresh dark berries. Polished tannins, plush textures and layers of sweet, ripe berries fill your mouth. The suave, fresh wine ends with an expansive, rich finish in the mouth. Very successful for the vintage. "Alfred Tesseron has been making classic Pauillac here every year since the excellent 1994 and recent vintages have been amongst the best ever, scoring impressively when shown in blind tastings. Pontet Canet is now pushing the Pichon's as Pauillac's top non-first growth. Grapes are manually sorted by a team of 30 people on specially made sorting tables. The vineyard is now 100% organic and bio-dynamic and worked by horses. 65% Cabernet Sauvignon, 30% Merlot, 4% Cabernet Franc, 1% Petit Verdot in 60% new oak. The yield is 32 hl/ha. There is a dark, saturated colour here. Black fruits, raisins, fruitcake, tar and liquorice are all present on the multi-dimensional nose. Huge, fat, and incredibly dense on the palate. There is an incredible concentration of black cassis fruit, yet the tannins are ripe and silky. Despite the power there is great purity and elegance. Another outstanding achievement here. Very pure cassis and blackcurrant fruit is offered, with so much weight, power and mint like freshness to the nose. The palate offers density and sweetness of fruit that is unmatched in any other wine, with sweet black fruit and a spiced cedar edge that guides you to the back of the palate. There is a real underlying precision, detail and freshness here once again. It doesn't have the structure or complexity of the really legendary years but once again Pontet-Canet lead the pack.
