General Info Chateau Branon is an old property whose high reputation dates back to the 18th

century. It is located in Léognan on the slope of a gravelly hill between Haut-Bailly and Malartic Lagravière. Its vineyards are particularly well exposed towards the south and south-west. The whole estate was in a very poor condition and partly abandoned when Sylvaine Garcin-Cathiard acquired it in 1996. Today it comprises of 6.5 hectares. It is mainly the diversity of its soil that gives the wine its character. The exceptional soil consists of clay and gravel washed up from the Pyrenees caused by the meanderings of the Garonne over time.

In former years the wine had indisputable fame as the old ruins of the Château and the chai testify. One of the Gironde's oldest stone wine presses can be found here. An ancient book - "Les richesses gastronomiques de la France, les vins des Bordeaux", written by Charles Lorbac, says that the merchants Schröder and Schyler bought the 1865 vintage at a price of 1800 F (Germinal) per "tonneau". The official documents of the classification of 1855 indicate that BRANON, at that price, was classified as a 4^{eme} cru.

Vineyards

The 6.5-hectare Bordeaux vineyard of Chateau Branon has a terroir of clay and gravel soil. It's planted to an even split with its 50% Merlot and 50 % Cabernet Sauvignon cepage. On average, the vines of Chateau Branon are close to 35 years of age. At Chateau Branon, malolactic fermentation is performed in barrel. The wines are aged in 100% new, French oak barrels. Production is tiny. Only 6,000 bottles of Chateau Branon are produced every year.

Maturation

It is aged for 16-18 months in new French oak.

Tasting Notes

With a very perfumed and balanced nose, the intense red fruit and a hint of earth

liven up the palate. It is concentrated, pure, and well structured.

Give it another 5-8 years of cellaring and drink it over the following 20+ years.

Sauvignon is absolutely sensational. The debut vintage, 2000, continues to show tremendous potential and

clearly reveals the high-quality terroir Branon possesses."

"The fruit from this vineyard, planted on a small outcropping of gravel close to both Haut-Bailly and Malartic-Lagraviere, used to be blended with Haut-Bergey until the Garcin family decided it had such an impressive potential that it had to be culled out. A blend of equal parts Merlot and Cabernet Sauvignon, the production is a tiny 6,000-8,000 bottles. The debut vintage, 2000, was one of the superstars of that superlative vintage. The 2010 reveals awesome potential. It offers a dense opaque purple color along with a glorious as well as classic Graves bouquet of smoky barbecue scents, blackberries, cassis, tobacco leaf and plums. Deep, full-bodied and pure with singularity, freshness and precision, this stunning 2010 should be accessible in 2-3 years and last for 2-3 decades."
