General Info	For the past four centuries, Château Haut Bailly has overlooked 28 hectares of vines in a single block. These grow on soil consisting of sand and gravel from the Tertiary period with a fossil stone subsoil. Haut Bailly's reputation as one of the very finest wines of Bordeaux was established in the 19th century. Haut-Bailly was bought by the Sanders family in 1955 and was run by Jean Sanders until 1998 when Robert G. Wilmers, an American banker, purchased it. Robert G. Wilmers continues to emphasise quality in all aspects of production, combining a blend of tradition and modernity with respect for the environment. Château Haut-Bailly's unique terroir produces wines that are outstandingly reliable, and whose prestige is due to an inimitable style marked by finesse and elegance.	
Vintage	Luckily, all the elements were present for 2009 to be an unforgettable vintage. The growth cycle of the vines and the ripening of the grapes took place in particularly favourable weather conditions, assisted by meticulous work in the vineyard. The rather dry and cold winter delayed bud burst by a fortnight, the Merlot and Cabernet flowered at the same time, around May 30. The great weather conditions in the summer were perfect for the ripening of the grapes and continued through to September, during which warm days were generally followed by cool nights. These conditions particularly favoured the concentration of flavours and the accumulation of pigments. The grapes were sweet, richly coloured, and fruity, in proportions similar to the greatest vintages. Vineyards	The Haut-Bailly estate accounts for 33 hectares of the Médoc, of which 30 hectares are vineyard, largely in a single block on a gravel <i>croupe</i> . The soils are a mixture of sand and Tertiary gravel over <i>Faluns de Léognan</i> , a subsoil rich in sandstone and ancient fossilised shells. The vines themselves are mainly Cabernet Sauvignon (64%), which are planted on the upper parts of the <i>croupe</i> and slopes where the drainage is best, with 30% Merlot, which are planted on those plots where the soils are richer in clay. The remaining 6% is Cabernet Franc, and overall the planting density is an admirable 10000 vines/ha.	
Harvest	Harvesting began on September 15 with the Merlot in the mornings, to avoid the afternoon heat and went on late into the season. The Cabernet Sauvignon and Cabernet Franc were picked on October 7 and 14.	
Maturation Tasting Notes	In small oak barriques (55% new) for 16 months and is bottled unfined and unfiltered. The wines' structure is characterized by a succulent texture and a very pure expression of ripe fruit resulting, in particular, from the alcoholic fermentation process, during which temperatures were kept at around 26°C. The structure presents a remarkable harmonious balance. The Merlots are superb while the Cabernets are powerful but incredibly creamy: these are real thoroughbreds. 2009 is an exceptional vintage.

"Offers a rich, very dense feel, but stays racy thanks to a strong graphite frame around the core of roasted fig, plum sauce and maduro tobacco. Muscular but defined on the finish, with a long tarry edge in reserve. This shows serious depth and is more backward than most of its peers. Should really stretch out nicely in the cellar. "A dense ruby/purple-tinged color offers up notes of forest floor, subtle wood smoke, mulberries, black cherries, cassis and a hint of lead pencil shavings. There is even a floral component lurking in the intricate aromatic profile. The wine is medium to full-bodied with wonderful intensity that builds incrementally and has a long, silky, luscious finish. There is plenty of tannin, but it is largely concealed by the wine's beautiful fruit and ethereal complexity. Given its virtually perfect balance, this brilliant Haut-Bailly should age effortlessly for 3-4 decades.

"This is a tour de force in winemaking, particularly for readers seeking the quintessential example of a Bordeaux that combines compelling complexity and finesse with significant flavor authority and intensity. I suppose we could see this coming as American owner, Robert Wilmers, along with his winemaker/manager, Veronique Sanders, continue to push the envelope. Yields were extremely low in 2009, and the final blend was an intriguing concoction of 60% Cabernet Sauvignon, 37% Merlot and 3% Cabernet Franc. It came in just under 14% natural alcohol, which makes it among one of the more powerful Haut-Baillys produced. However, power is not the hallmark of this wine. This terroir is known to produce relatively light wines, and by reducing yields and picking riper fruit, Wilmers and Sanders have achieved a level of concentration and intensity that is unprecedented for Haut-Bailly. That said, they have not lost any of these wines' stunning elegance, finesse or aromatic complexity." - RP, Wine Advocate

"The greatest Haut-Bailly ever made? One can't speak enough of the job Veronique Sanders has done in 2009, allied with the owner, the American banker Robert Wilmers, who has given her carte blanche authority. Tiny yields have resulted in the most concentrated Haut-Bailly I have ever tasted. Eclipsing even the 2005, the 2009 (a blend of 60% Cabernet Sauvignon, 37% Merlot, and 3% Cabernet Franc) possesses 13.9% natural alcohol. Dense purple to the rim, it exhibits a precise, nuanced nose of mulberries, black cherries, black currants, graphite, and a singular floral component. A wine of profound intensity and full-bodied power, yet stunningly elegant, and never heavy or massive, it builds incrementally on the palate, and the finish lasts over 45 seconds. Remarkably, there is not a hard edge to be found in this beauty. The Cabernet Sauvignon and Cabernet Franc were harvested between October 7 and 14, which explains their phenolic maturity. The nose is very well defined with superb delineation with tightly wound scented of blackberry, bay leaf, black olive and a touch of crushed stone. Very Graves-like. The palate is very well balanced with fine tannins and tension. Very feminine but there is good backbone here, graceful towards the finish. Superb. Tasted November 2011." - NM, Wine Journal **Reviews** *"Tasted at the chateau, the sample taken 16th March from a pre-blend of the Merlot and three lots of Cabernet (probably no pressed wine this year) and a second sample at a negociant. A blend of 60% Cabernet Sauvignon, 37% Merlot and 3% Cabernet Franc with 55% new barrels. A very deep garnet/black colour. This has a very refined nose of blackcurrant, raspberry, wild hedgerow, a nice minerality all with very good delineation but very tightly wound at the moment: this really does demand coaxing from the glass. With further aeration, that minerality is really coming through nicely (much more so than at the chateau!) The palate is full-bodied with a soft entry, grippy tannins, structure on the entry, dense black ripe fruit with an underlying stoniness. It is the follow through, like a wave crashing onto the back palate that really marks this wine out, with very fine persistency and minerality towards the finish. Silky and slightly creamy in texture towards the finish. Superb. Tasted April 2010."*

"Medium ruby-red. Very ripe but subdued aromas of dark berries, black cherry, minerals, woodsmoke, mocha and smoky underbrush. Silky on entry, then utterly smooth and seamless in the middle, with outstanding concentration and lift to the berry, tobacco and hot rock flavors. Finishes with utterly noble tannins and outstanding, slowly building length and lingering perfume. This outstanding Haut-Bailly saturates every square millimeter of the palate without leaving any undue impression of weight. I was reminded of the time I was served three classy old Pessac-Leognan wines blind. I guessed that I was tasting Haut-Brion, but the bottles turned out to be Haut-Bailly 1961, 1945 and 1928."

"Deep ruby. Highly perfumed nose is brimming with blackcurrant, blackberry and violet; shows an almost fruit cocktail quality. Then smooth, dense and lush, with noteworthy intensity to its fresh black fruit flavors complicated by stony minerality and exotic herbs. "Dark, slightly earthy on the nose, spicy, with a dense, dark suggestion of concentration. There is a bright and firm substance to it on the palate, the wine showing a very bold, tightly compacted character, tense and rather reticent rather than the softer flesh or grippy weight found in some wines tasted alongside. Highly polished, taut rather than fleshy, with great power behind it, this is savoury, dense and forceful. It manages to combine Graves composition with a weighty, impressive backbone. Cabernet Sauvignon 60%, Merlot 37% an Cabernet Franc 3% fermented at 26°C, cooler than usual, a response to the massive presence of tannins in this vintage. IPT 70, 55% new barrels, alcohol well controlled at 13.4%. A very dark and concentrated hue here. The nose has a warm style of fruit, with a macerated cherry and red-black forest fruit character, although it has perfume too, with some floral elements peeping through the dark exuberance. The palate kicks off in a very ripe and soft style, although richly imbued with tannins, which have a velvety, fur-coat-feel to them. Rich, creamed, honeyed fruit, fresh, the tannins prodigious but very much in harmony with the wine. Fresher on the palate than I expected from the nose though, with quite vigorous acidity balancing out the warm piles of substance. Elegant despite all that texture underneath. Perfumed finish. And it is incredibly long. This is monumental, especially so for Haut-Bailly. Could be a great wine given cellar time. From my 2009 Bordeaux primeur assessment. 18-19+/20 (March 2010)"

2009: This remarkable estate has strengthened in such a short period of time. It has produced another stunning wine that competes with the big 2008. The gorgeous, saturated ruby/purple hued Haut-Bailly offers a striking perfume of pain grille, a la plancha meat juice, savory blackberry, crème de cassis, and stone-dust. Sensational richness is combined with a medium to full-bodied, dense mouth-feel, savory cassis, and a beautiful expansion on the finish. This is a big, complex wine that is youthful in its evolution and potent in flavor. There is upside potential for this sumptuous Haut-Bailly! Maturity period 2017-2032.
