For the past four centuries, Château Haut Bailly has overlooked 28 hectares of vines in a single block. These grow on soil consisting of sand and gravel from the Tertiary period with a fossil stone subsoil. Haut Bailly's reputation as one of the very finest wines of Bordeaux was established in the 19th century. Haut-Bailly was bought by the Sanders family in 1955 and was run by Jean Sanders until 1998 when Robert G. Wilmers, an American banker, purchased it. Robert G. Wilmers continues to emphasise quality in all aspects of production, combining a blend of tradition and modernity with respect for the environment. Château Haut-Bailly's unique terroir produces wines that are outstandingly reliable, and whose prestige is due to an inimitable style marked by finesse and elegance.

Vintage

The 2012 vintage plays like a foxtrot – in four defined steps... First, following a cold dry winter, a cool, wet spring made the flowering process difficult and threatened some of the Merlot vines with "coulure". Then, as cool temperatures persisted until the beginning of July, we kept an extra careful eye on the vineyard and fought the onset of diseases (mildew, oïdium). The team remained on hand throughout the summer. A third step would be the month of August with the advantage of wide temperature ranges with hot days - as sunny as in 2000 or 2009 - and cool nights. All which favour the synthesis of anthocyanin. Traditional tilling of the soil allowed better management of hydric stress. Finally, at the end of a summer-like month of September, a few millimeters of rain on September 25th and 26th helped to re-kindle the ripening of the grapes, which led to the sublimation of the fruity character of the skins and the softness of the tannins.

Vineyards

The Haut-Bailly estate accounts for 33 hectares of the Médoc, of which 30 hectares are vineyard, largely in a single block on a gravel *croupe*. The soils are a mixture of sand and Tertiary gravel over *Faluns de Léognan*, a subsoil rich in sandstone and ancient fossilised shells. The vines themselves are mainly Cabernet Sauvignon (64%), which are planted on the upper parts of the *croupe* and slopes where the drainage is best, with 30% Merlot, which are planted on those plots where the soils are richer in clay. The remaining 6% is Cabernet Franc, and overall the planting density is an admirable 10000 vines/ha.

Harvest

The harvest started when the phenological maturity (tannins) caught up with the technical maturity (sugar, acidity). The Merlots were picked in ideal conditions. The weekend of October 7th was especially hot and wet, causing us to quicken the pace and pick the Cabernets before the return of the rain. The Merlots were pleasant and full of charm. The Old Vines delivered splendid Cabernets, typical of the great terroir of Haut-Bailly.

Maturation Tasting Notes In small oak barriques (55% new) for 16 months and is bottled unfined and unfiltered.

Fruity, fresh and dense, the 2012 vintage has tight tannins and expresses the

virtuosity of Haut-Bailly.

"Well-stuffed, with thick and muscular brambly structure that easily supports the core of macerated black currant, fig and boysenberry fruit flavors. A tarry edge coats the finish. More backwards than most of its peers at this early stage, but all the elements are in place. Best from 2018 through 2027. 6,665 cases made."

"The classic 2012 Haut-Bailly is staggeringly great wine, with a stunning bouquet of lead pencil shavings, blueberries, black raspberries and blackcurrants and perhaps a touch of spring flowers, followed by a medium to full-bodied wine with an almost seamless integration of wood, alcohol and tannin. It is rich, concentrated, stunningly supple, pure and a total hedonistic and intellectual turn-on. This wine defines what is meant by intensity of flavor, but it is light on its feet, à la great cuisine. It should be drinkable reasonably young, but age effortlessly for 25-30 years.

One of the great shining superstars of Pessac-Léognan has been the ascent of Haut-Bailly under the ownership of Robert Wilmers, an American, and his winemaking team lead by Véronique Sanders. "The Grand Vin is a blend of 60% Cabernet Sauvignon and 40% Merlot, picked between September 27th and October 15th. The nose is comparatively reserved, broody black fruit, wild strawberry and hint of cedar. It is nicely focused, less precocious than recent vintages. The palate is soft and very smooth on the entry. Velvety soft tannins, although it needs just a little more lift on the mid-palate. It is quite linear towards the finish, quite

"Dark ruby in color, the wine opens with framboise, licorice, cocoa powder, smoke, and caramel. Produced from a blend of 60% Cabernet Sauvignon with 40% Merlot, the wine reached 13.2% alcohol with a pH of 3.6. Wine will be aged in 50% new French oak for 16 months. This is a finesse style of Haut Bailly with fresh and ripe red and black fruits that display a lot of purity and freshness. The wine ends with sweet black raspberry and cherry sensations in a forward, spicy finish. 92-94 Pts"

"Not many châteaux in Bordeaux are blessed with as fine a terroir and a chatelaine as exquisite as Véronique Sanders, but Ch. Haut-Bailly has both. Véronique mentioned that after the highs of 2009 (£450.00/6) and 2010 (£516.00/6), she wanted to get her 2012 back within the reach of buyers perhaps 'priced-out' as well as attract some new ones.

The 2012 is a commendable reduction on the 2011 (£294.00/6) – and it is a very fine Ch. Haut Bailly indeed. It has great depth, and a warmth, but with structure there too, with all that old-vine intensity and classis Graves freshness that makes this one of the few Bordeaux to consider every vintage. It will take on more volume in time and prove as rewarding as any Haut-Bailly of the last 15 years. For me it is one of the wines of the vintage (true, it always is.)."

"Possessing a warm and heavy coco content, Ch. Haut-Bailly has a dark, rich, chocolate nose which is outstanding and lures you in like a siren. "Very dark fruits on the nose here, black cherries and plums, sweet and very bright and perfumed. The palate has a very elegant composure, with polished and balanced fruit substance, the tannins broad and substantial, but feel well-polished and cottony, and seem to sit within the substance of the wine rather well. Some notes of black cherries and cream complete the slightly floral fruit freshness seen on the nose.
