General Info The von Neipperg counts are descended from a noble line dating back to the Holy Roman

Empire. This family has contributed great soldiers and illustrious diplomats throughout the centuries. Responsible for numerous military exploits, the family's long history is grounded in their attachment to their land. In fact, the Counts von Neipperg have been

making fine wine there since the 12th century.

In 1985, Stephan von Neipperg was officially named estate manager and proceeded to make in-depth changes at Canon La Gaffelière. He started by making a complete analysis of data concerning his vineyard and then drew logical conclusions of what needed doing. His collaboration at a later date with e also contributed to Canon La Gaffelière's

reputation around the world.

Winemaker Stephan von Neipperg

Vintage The year 2020 had harsh weather conditions that disrupted vine growth. The year

started off with heavy rainfall that was beyond historical averages. A combination of rain and cold temperatures led to the widespread outbreak of mildew. Fortunately, the effects of mildew subsided when temperatures rose in April and May. in fact, there were a few estates that reported losing a significant number of grapes due to mildew (unlike in 2018.) There was no rain between mid-June and mid-August, and most estates (like Saint Emilion and Margaux) reported dehydration on the Cabernet Sauvignon vines. Additionally, the grapes were smaller in size, and the yield was very low. The Merlot grapes were harvested around mid-September, while the Cabernet grapes were picked

about a week later.

Vineyards The 19.5-hectare vineyard has a complex, outstanding terroir of clay-limestone and clay-sand soil. The topsoil is

primarily sandy, increasingly so as one moves away from the slope. The vines, an average of 45 years old, are deeply rooted in the soil and absorb all the goodness in the terroir. They are mostly replaced individually rather than plot by plot (which maintains the average age). The last major replanting dates back to 1986. Mass selection is practiced. This is especially useful in order to perpetuate the precious old Cabernet Franc vines. It

not only maintains the vineyard's genetic heritage, but also its unique balance

Harvest By hand, into small crates to avoid bruising. A yield of 32.5hl/ha

Vinification/ Fermentation in wooden vats for 35 days. Extraction by pneumatic pigeage (punching down the cap) Ageing in

Maturation new oak barrels (50%) on the lees for 16 months. No fining.

Tasting Notes A more modern style than most others among the *Premiers* but with a delectably juicy mid palate. Canon La

Gaffelière (St Emilion; from a vineyard of 19.5 hectares at the foot of the slope, down the hill from Ausone on *argilo-calcaire* and *argilo-sableux terroirs*; 55% Merlot; 30% Cabernet Franc; 15% Cabernet Sauvignon; certified organic; final yield of 32.5 hl/ha; aged in French oak barrels, 50% of which are new; 13.5% alcohol). Lightly extracted and with a shimmering limpidity in the glass that seems to capture well the luminosity of the wine itself. The nose is a beautiful study in tension itself, between the fresh vertical lift of the pure almost crunchy berry and cherry fruit and the stony, gravelly, graphite and cedar minerality and wild herbs that are both so

equally present.

"A blend of 50% Merlot, 35% Cabernet Franc and 15% Cabernet Sauvignon, the 2020 Canon la Gaffelière offers up inviting aromas of dark berries, plums, burning embers, rose petals, incense and bay leaf. Medium to full-bodied, velvety, and layered, it's suave and perfumed, with melting, powdery tannins, and a vibrant core of fruit. As ever, the elevated percentage of Cabernet Franc lends it a singular and compelling style.

Located at the foot of the Saint-Émilion's southern slope, Canon la Gaffelière's 20 hectares of vineyards are planted with some 40% Cabernet Franc and 10% Cabernet Sauvignon, the balance being Merlot. Farming is certified organic, with thoughtful use of cover crops, agroforestry initiatives, unhedged canopies, and late pruning. Macerations are long but gentle, and new oak is increasingly chosen for discretion over impact. The result is wines of textural sensuality and striking aromatic range, delivering all the fireworks that Cabernet Franc at full maturity can display."

"On the nose, fruity, fresh, offering depth, a nice stretch, a nice finesse of grain as well as some richness and concentration in subtlety/balance. The palate is fruity, elegant and offers a beautiful freshness, a nice definition, precision, gourmandize, a little richness (in freshness and finesse), roundness, subtlety, plenitude, minerality and precision. On the palate it expresses notes of boysenberry, bright cassis and more lightly bright small blue fruits associated with hints of lilac, blueberry, subtle hints of saffron, black tea as well as discrete hints of tonka bean, toast, and a discrete hint of toasted hazelnut. The tannins are precise and finely mellow. Good length. The presence of a little chewiness and a subtle sapid point on the finish/persistence. A wine full of finesse, delicacy, and plenitude."
