Chateau Larcis Ducasse had its birth during the days of the ancient Romans. The modern era for Larcis Ducasse begins in 1893, when Henri Raba bought the St. Emilion vineyard. After Henri Raba passed away in 1925, his wife and son Andre Raba continued managing Larcis Ducasse. Andre died during World War 2. His niece, Helene Gratiot Alphandery, inherited the property in 1941. She managed Larcis Ducasse until 1990. Her son, Jacques-Olivier Gratiot took control of the property after she passed away and he remains in charge today.

Larcis Ducasse remains the property of the Gratiot Alphandery family. Prior to 2003, it had been years since the wines of Larcis Ducasse were prized by Bordeaux wine lovers. The wine had fallen out of favor. That changed in 2002 when they hired the team of well-known St. Emilion consultants, Nicolas Thienpont and Stephane Derenoncourt to turn things around and manage the estate. One of the first improvements to the property suggested by Nicolas Thienpont and Stephane Derenoncourt was to create a new drainage system. The next step was to change harvesting practices. Now, the harvest takes place when the fruit is ripe, and the picking can take as long as 2 to 3 weeks to complete.

Winemakers Vintage

General Info

2020 was a highly contrasted vintage that got off to a difficult start. The year began with an exceptionally rainy winter followed by a very mild spring. In this context, protecting the vines against mildew and managing the soil was a real struggle. The first miracle appeared in mid-May, with dry and warm conditions during one of the earliest flowerings we have seen, two weeks ahead of schedule. The second miracle was on 19 June when the rain stopped, and the weather turned dry and cool until the beginning of the grape colour-change in mid-July. It is at this point in time that summer settled in for good, with some spells of heat through to mid-August when thunderstorms provided some relief and allowed the Merlot grapes to swell. The later-ripening Cabernets remained the size of blueberries until harvest, and the Merlots will ripe slowly until mid-September. The result was a vintage harvested about ten days early, mostly in sunny conditions. Both the Merlot and Cabernet were tannic, colourful and perfectly balanced. The grapes quickly expressed an intense aromatic expression in the vats.



Vineyards

The 10.85 hectare St. Emilion vineyard of Larcis Ducasse is located just around the bend in the road from Chateau Pavie . In fact, their vines abut each other. The terroir of Chateau Larcis Ducasse is a mixture of soils with vines on the plateau and the slopes with a south facing exposure. At the higher elevations on the plateau, the terroir is limestone and clay soil. As you travel further down the slopes the terroir is a blend of chalky limestone, marl, sand, and clay soil. The vineyard is planted to 78% Merlot and 22% Cabernet Franc . This shows a change in the vineyard, as more Cabernet Franc has been added to the plantings since 2003. On average the vines are 35 years of age. While the older plantings were done at a vine density of 6,600 vines per hectare, as the vineyard continues to be slowly replanted, the vine density is increasing. The new plantings are being done at 7,500 vines per hectare. They are also using budwood obtained through selection massale. The yields are kept low at Larcis Ducasse.

Harvest Winemaking

Merlot from September 15 to 29. Cabernet Francs on September 29. Yield: 38.8 hl/ha (72% great wine) To produce the wine of Chateau Larcis Ducasse, the grapes are whole berry fermented. The fruit is transported by gravity flow into traditional cement tanks for fermentation. Cuvasion takes between 25-28 days. There are no pump overs. Pigeages are conducted during fermentation. Malolactic fermentation takes place in the



Winemaking barrel. The wine of Chateau Larcis Ducasse is aged in 50% new, 50% 1-year old, French oak barrels for an

average of 16-18 months.

Tasting Notes In this 2020 vintage, the Cote of Larcis-Ducasse hillside was revealing all its Premier Grand Cru Classe quality.

With a striking contrast between a spring marked by the rain and a dry summer, the vines of Larcis enjoyed all the right conditions to temper and balance the excesses of the climate. And in this sun-drenched terroir, the

dense, fresh dynamic character of the wine really came into its own.

Serve with Chateau Larcis Ducasse is best paired with all types of classic meat dishes, veal, pork, beef, lamb, duck, game,

roast chicken, roasted braised and grilled dishes.

"A beautiful effort that's more sensual and seamless than Thienpont's more structured, brooding Pavie Macquin, the 2020 Larcis Ducasse unwinds in the glass with aromas of cherries, blackberries, bay leaf, rose petals and licorice. Medium to full-bodied, layered and concentrated, with refined tannins, lively acids and a suave, fleshy profile, it concludes with a long, expansive finish. This is a particular success in 2020. Managed by Nicolas Thienpont and David Suire since 2002, Larcis Ducasse occupies an 11-hectare block adjacent to Pavie. Some 15% of the vineyard sits on the plateau at the top of the slope, but these holdings are being restructured and contribute only a small percentage to the blend for the time being, so this is truly a "vin de coteaux"—a wine from the slopes. Soils are mainly molasses du Fronsadais clays over limestone, but a diversity of expositions and strata means this is an inherently complex terroir. As is the case along the whole Côte de Pavie, springs percolate throughout the vineyard, so Larcis Ducasse combines cool, hydrated soils with a warm meso-climate and a sunny exposition. Supple and seamless, Larcis is less tensile and incisive than Pavie Macquin from the plateau above, tending to develop complex aromas of black truffle with bottle age and typically concluding with a mouth-wateringly saline finish. New plantings are at a density of 8,800 vines per hectare, using massal selections of Cabernet Franc, and winemaking emphasizes whole berries and long macerations with punch-downs."

"The Grand Vin comes from a tiny 11.15-hectare vineyard that has been in the Gratiot family since 1893. Located on the south-facing Côte Pavie, between Château Pavie and Château Bellefont-Belcier and consisting of clay on top of limestone soils, the vineyard has recently been going through a replanted phase using a selection massale and a higher density planting. The grapes are hand-sorted, vinification occurs all in concrete and spans four weeks, with the élevage in 50% new French oak. A normal blend of 90% Merlot and 10% Cabernet Franc, the 2020 Château Larcis Ducasse reminds me of the 2005 and is up with the top handful of wines on the Right Bank. It has a brilliant perfume of red and black fruits, white truffle, leafy tobacco, and Asian spices. This carries to a full-bodied, concentrated, powerful Larcis-Ducasse with ultra-fine yet building tannins, perfect balance, a stacked mid-palate, and one heck of a great finish. It's going to flirt with perfection in 7-8 years (I'm probably underrating it a point) and have 30 years of overall longevity. Tasted numerous times with consistent results."

"A wine that's going to flirt with perfection is the 2020 Château Larcis Ducasse. It's a Saint-Emilion with an almost Pomerol-like depth and power paired with classic Saint-Emilion aromatics and minerality.
