One of the oldest Medoc estates, Domaine de Léoville belonged to some of the wealthiest and most influential noble French families before it was acquired by the Las Cases family. The estate was split up between 1826 and 1840 as a result of the French Revolution. (Expropriation of emigrants' property and constitution of egalitarian redistribution). Château Léoville Las Cases was created, thanks to a kind of birthright, from 3/5 of the original estate and the heart of the domain.

The Grand Vin's current *terroir* has therefore been at the historic heart of the original *terroir* since the 17th century. Pierre Jean, Adolphe and Gabriel de Las Cases were successive heirs to the property until 1900, when Théophile Skawinski purchased a share in the estate and became its manager. Léoville Las Cases has now been managed by the same family since the late 19th century and is today represented by Jean-Hubert Delon, sole owner of the Château and proprietor of Château Potensac in the Medoc and Château Nénin in Pomerol.

Created in 1902, the Clos du Marquis has its origins in the "Petit Clos" adjacent to the Château de Léoville, home of the Marquis de Las Cases. The Clos du Marquis comes from the great terroirs of the Saint-Julien appellation that were not part of the former Léoville estate.

These terroirs are located further west and surrounded by prestigious Crus Classés (Classified Growths) including Second Growths from the Saint-Julien and Pauillac appellations: Léoville Poyferré, Léoville Barton and Pichon Longueville Comtesse de Lalande. The Clos du Marquis thus displays typical Saint-Julien characteristics: structure, complexity, balance, distinction and great ageing potential. Clos du Marquis has the ability to challenge many other châteaux of the Medoc. Indeed, it is the equal of most 3rd, 4th and 5th Growths and has been an outstanding performer for many years.

Vintage

The buds burst at the beginning of April, after a dry and rather cold winter. The blossoming began in the last week of May in good weather conditions and was quick and even on all the grape varieties. The hydric stress became more visible throughout June, stunting the growth in the young grapes and limiting their size early in the summer. The colour change was quick and even and the bunches continued to ripen through August, which was still very dry and sunny, although not excessively hot. These ideal conditions resulted in very concentrated and perfectly balanced grapes.

Vineyards

As Clos du Marquis hails from a separate vineyard it is a separate cuvée – and not a Second Wine. The grapes are grown in the Petit Clos (Clos meaning an enclosed garden or field) which is surrounded on all sides by other Second Growths. The Petit Clos vineyard is to the south of the Léoville Las Cases Grand Clos vines and covers 12 acres. It is planted with 57% Cabernet Sauvignon, 38% Merlot, 3% Petit Verdot and 2% Cabernet Franc.

Harvest

From 21st September to 7th October 2005

Vinification/ Maturation At Léoville Las Cases, the wine making remains traditional. Grapes are harvested by hand and fermented in temperature-controlled wood, concrete, or stainless-steel vats of varying size. The stainless-steel tanks range from 40 hectoliters all the way up to 216 hectoliters. The oak vats also range in size from 176 hectoliters up to 270 hectoliters per vat. The oak vats also range in age, with the oldest vats dating back close to 50 years! Malolactic fermentation takes place in tank.

Aged for 20 months in French oak (20% new oak).



**Tasting Notes** 

Clos du Marquis's grapes actually come from a separate area of vineyards (rather than younger or less successful vines at Léoville-Las Cases) surrounded on all sides by other Second Growths. This is made with much more Merlot (38%) than the Léoville-Las Cases and is very rich, with sweet, creamy, overripe raspberries and blackberries with leather overtones. It is a very precise wine within a beautifully integrated framework of new oak and classy tannins. This is a cracking Claret and one of the best value wines of the vintage.

"The Clos du Marquis 2005 is evolving into a little beauty. It has an opulent, downright sexy bouquet with macerated dark cherries, briary, mint interlaced with candied orange peel that is beautifully defined. The palate is medium bodied with sturdy tannin cloaked in spicy red fruit, hints of red peppercorns and graphite infusing the finish that fans out gloriously. Yet everything remains tightly controlled thanks to the tight rein on acidity. Cannot afford Léoville Las-Cases? Then you know where to come."

"Tasted at Roberson's Las-Cases vertical. A dark garnet core. The nose is youthful and very well defined with blackcurrant, a touch of truffle and pencil shavings, lending this a Pauillac-like personality.
