General Info The prestigious Bordeaux property of Gruaud-Larose, a 2nd growth in the 1865

classification, lies in the commune of Saint-Julien, a single vineyard of 80 hectares composed of gravels from the Gironde estuary. The poor soils provide excellent drainage, especially as the vineyards are on the highest plateau of

Saint-Julien - though that is a mere 18 metres above sea level.

Gruaud was one of the first Bordeaux estates to abandon synthetic pesticides and herbicides in the vineyard during the late nineties, turning to mechanical and organic solutions to protect and nourish the vines. Though not biodynamic, they do employ natural homeopathic treatments such as organic compost made

from seaweed to protect against mildew and rot.

Vineyards The Gruaud-Larose estate amounts to 150 hectares of the St Julien appellation,

of which 82 hectares are planted to vines; the bulk of the estate lies around Baron Sarget's *château*, separated from the Gironde by the small village of Beychevelle, and sandwiched between the vineyards of Branaire-Ducru and Lagrange. The terroir is typical for the region, deep Quaternary gravel, planted with 57% Cabernet Sauvignon, 30% Merlot, 8% Cabernet Franc, 3% Petit Verdot and 2% Malbec. The vines average around 45 years of age and are planted at a

density of 10000 vines/ha.

Maturation The fruit is sorted then undergoes a cold soak prior to temperature controlled

fermentation in a mixture of wooden and concrete vats, with pumping over of the fermenting must twice a day. Then up to a third of the vintage undergoes malolactic in oak barrels, before ageing the entire wine in *Alliers* and *Nevers* oak (up to 50% new) for 18 months, and there is a light fining and filtration before

bottling.

Tasting Notes There is an earthy complexity on the nose of the 2009 Gruaud Larose that adds

immediate interest to the massive intensity of dense blackcurrant fruit lying underneath. The cassis-driven palate is pure, subtle and gentle with a beautiful, balancing freshness and ripe tannins which just disappear on the palate. This is

a very generous, rewarding wine.

"As I wrote in my barrel tasting note, the 2009 appears to be the finest Gruaud Larose since their 1990. Some of my concerns about too much Brett in previous vintages are long gone as the purity of the 2009 jumps out. Copious notes of sagebrush, cedar, cigar box, licorice, incense, blackberries and lead pencil shavings suggest a big Pauillac rather than a St.-Julien. Broad, rich and full-bodied with good balance and abundant, but sweet, well-integrated tannin, this big, masculine Gruaud Larose reveals remarkable finesse, richness, extract, density and a cascade of fruit that nearly hides the lofty tannins. "Tasted at the chateau and the UGC. The crop was picked between 23rd September and 29th September for the Merlot and 2nd October to 17th October for the Cabernet Sauvignon. A blend of 68% Cabernet Sauvignon and 32% Merlot, this Gruaud has a tightly wound nose of black cherries, a touch of black plum and black truffle, good definition and with time some more exotic aromas: hints of honey and a little espresso. The palate is medium-bodied, very linear on the entry but displaying very good definition, with notes of blackberry, a touch of raspberry, espresso, a little white pepper and a meaty character. It expands very well towards the finish, maintaining excellent definition and clarity, very good poise, a biscuit element inflecting the pure black fruits, an insistent but gentle grip and great persistency. "(a blend of 65% cabernet sauvignon and 35% merlot; 13.35% alcohol; pH 3.85; 76 IPT; 40% selection) Deep ruby. A very classic nose of cassis, cedar and smoky graphite is devoid of animal and earthy scents and conveys a sense of refinement rare for this wine. Then very smooth in the mouth, with excellent palate presence and sneaky concentration to its sweet, ripe black fruit and smoky peppery flavors. Lively, harmonious acidity leaves an impression of freshness on the long, dense finish, which features a touch of dried herbs and oaky torrefaction along with a trace of heat. As ripe and spicy as this is, it's an unusually graceful Gruaud Larose, one of this estate's most successful wines in memory. Call me fixated, but I can't help but think that making the grand vin from just 40% of the total crop has everything to do with the quality of this wine. It cannot be a coincidence that almost all of the best wines in '09 have this in common."

"A really perfumed, spicy, earthy intensity here, lifted with notes of sandalwood, no doubt oak-influenced to some extent. Gentle and elegant on the palate, supple, with a savoury and earthy edge to it matching that found on the nose. Overall, I find the character of the wine very attractive, especially as it provides a respite from the sweet flesh of the vintage.
